



 - e) To grant aid or render assistance to other public chartable trusts or institutions having objects Similar to this Trust.





- 10) The Board of Trustees shall not exceed 7 Trustees at any point of time.
- 11) Any Trustee shall be liable to be dismissed from the trusteeship if he/she is adjudged insolvent or found insane or found guilty in a court administering criminal law.
A Trustee shall also be liable to be expelled from the Trusteeship, if his/her actions are adverse to the interests of the Trust.
